There may be additional court costs assessed to the full violation amount by the court if the Hearing Officer finds you liable. Failure to appear may result in a \$30 Failure to Appear fee. Failure to satisfy any civil penalties, tolls, and fees after entry of a Hearing Officer's Final Order may result in the Colorado Department of Revenue preventing **vehicle registration and/or your account may be assigned to an outside collection agency.***
